## 1. Call to Order.

Mr. Jose Graveley, Board President, called the Regular Meeting of the STWA Board of Directors to order at 5:30 p.m. A quorum was present.

## 2. Citizen Comments.

Mr. Graveley opened the floor to citizen's comments. No comments were made.

## 3. Approval of Minutes.

Ms. Rodgers made a motion to approve the minutes of the December 20, 2022 Regular Meeting, January 17, 2023 Public Hearing, January 17, 2023 Regular Meeting and January 31, 2023 Regular Meeting as presented. Mr. Galvan seconded. The motion passed by unanimous vote.

## 4. Quarterly Report/Treasurer's Report/Payment of Bills.

Ms. Wagner stated that due to software issues, the Treasurer's Report was not complete. She presented the STWA Quarterly Report for Quarter ending December 31, 2022. No bills were presented for payment. Mr. Galvan made a motion to approve the Quarterly Report, Ms. Lowman seconded and all voted in favor.

The Board reviewed the O&M and CP reports. Ms. Lowman asked about pending taps and Mr. Gomez responded that progress is being made on outstanding taps. Ms. Lowman also asked about the status of Field Technicians' licensing exams and Mr. Gomez stated that the Field Technician who most recently sat for the exam was very close but did not pass.

#### 6. STWA Master Plan.

Mr. Marez presented a tentative list of proposed projects to be provided to Water Finance Exchange to assist in submission of a Project Information Form to the Texas Water Development Board. He explained that the list is a starting point and asked for the Board's feedback. He added that once submitted, if the Project Information Form is approved for further action, a more detailed list will need to be completed in order to seek out funding. Mr. Morales made a motion to approve the Master Plan and any necessary modifications. Mr. Galvan seconded. The motion passed unanimously.

5. Petition for Addition of Certain Lands to the South Texas Water Authority and setting of public hearing date, time and place (Adam Edward Frederiksen, South half of Tract 23 and all of Tract 24, Cyndie Park Unit 2 in Nueces County, Texas).

The Board reviewed the Annexation Petition. The property owner recently approached the Nueces Water Supply Corporation requesting service outside of the Authority's district boundaries and filed an Annexation Petition to begin the process of obtaining water service on the property. Mr. Marez recommended approval of Resolution 23-05 setting the Public Hearing on March 28, 2023 at 5:30 p.m. at the STWA conference room.

Re: CP Update

For the month of February 2023, no changes to Contract 2 at this time. Martin Marietta, has started cleaned up our easement so that we have access to install anodes but not completed. CP crew has installed 576 anodes on 397 joints on Contract 2 of the 42" water line. We have replaced 46 old test stations since the beginning of the project. We have completed 45,259 feet out of 51,511 feet in Contract 2. In the meantime, the CP crew has relocated Contract 3. We have been working in Calallen south of Hummingbird Lane and have now installed 115 anodes on 94 joints and 3 test stations on the 42" water line. Compared to last month's report of 112 anodes and 86 joints. We have completed 3,808 feet out of 46,324 feet in Contract 3. Once all Contracts are complete, we can contact to submit quotes for a survey to determine continuity throughout the 42" water main, but the crew has remained busy with other CP related tasks and assisting with other field work for all three entities.

## We continue to work on CP related work and helping with other field personnel as follows:

- Perform maintenance and test rectifiers/test stations.
- Maintain grass with herbicide around vaults, manholes, test stations and rectifiers along 42" line.
- Exercise valves on 42" water main @ FM 2826, Driscoll, Bishop, CR 36, Stevens Plant & Kingsville valve.
- Perform locates for 42" water main.
- Assist O&M with ongoing operations.
- Worked on getting quotes for a new rectifier on CR 28 & Highway 77 to provide better Cathodic Protection for Contract 2.

## Background:

On February 28, 2023 the South Texas Water Authority approved holding an Annexation hearing set for its March 28, 2023 Board Meeting. Property owners requesting retail water service from the Nueces Water Supply Corporation are required to be annexed into STWA's district boundaries. This results in the new NWSC member paying the same costs as all other NWSC customers, specifically, a retail water bill from NWSC and property taxes to STWA.

Adam Edward Frederiksen requests retail water service from the Nueces Water Supply Corporation and annexation into the STWA's boundary. This brings about in the new NWSC member paying the same costs (NWSC retail water bill and STWA property taxes) as all other NWSC customers.

## Analysis:

The annexation petition and property described is owned by Adam Edward Frederiksen and seeks entry into the STWA's district boundary. This is similar request to previous petitioners that the Board has approved admittance into the STWA area and as a NWSC retail customer.

## Background:

Over the past several months the board has received presentations and entered into agreements with various groups to ensure we have experts providing engineering and financial services to pursue our shortand long-term goals. This item is an additional step to prepare the STWA's system to pursue funding options proactively to seek state, federal or other funding sources for repairs or new infrastructure needs.

Authorizing the services of Daniel Martinez with the Winstead Firm prepares the STWA to have legal counsel in place should we need to seek out particular funding options that require bond counsel.

#### Analysis:

If a governmental issuer such as a city, county, utility, rural water district or school district (the "issuer") is planning a project which may or will be paid in whole or in part with proceeds from tax-exempt bonds, notes or other obligations (the "bonds"), it is important to adopt a reimbursement resolution early in the process. This allows the issuer to reimburse eligible project expenditures that it paid prior to the closing of the bonds from other funds of the issuer, such as the general fund.

It is not uncommon for an issuer to start paying certain project costs, such as architect fees, survey and soil testing costs and initial site work costs prior to the receipt of bond proceeds. The reimbursement of project expenditures paid prior to the issuance of the bonds from those bond proceeds is subject to certain reimbursement rules.

#### Staff Recommendation:

Approve entering into a Bond Counsel Engagement Agreement and approve Reimbursement Resolution for any future bond or finance work.

#### Board Action:

- (1) Approve entering into a Bond Counsel Engagement Agreement with Daniel Martinez
- (2) Approve Reimbursement Resolution as presented

## Summary:

Adopting a reimbursement resolution and complying with these rules qualifies the STWA for refunds of those project expenditures from bonds or other finance sources. Having a Bond Counsel hired for our future projects ensures we are prepared to pursue upcoming funding options to respond to our infrastructure needs.

#### **RESOLUTION NO. 23-08**

## RESOLUTION DECLARING INTENTION TO REIMBURSE CERTAIN EXPENDITURES

WHEREAS, South Texas Water Authority (the "Authority") desires to pay expenditures in connection with the design, planning, acquisition, construction, equipping, and/or renovating of the project or facilities described in Exhibit A attached hereto (the "Project");

WHEREAS, Chapter 1201, Texas Government Code (the "Code") permits the Authority to use the proceeds of obligations to reimburse the Authority for costs attributable to the Project paid or incurred before the date of issuance of such obligations; and

WHEREAS, the Authority finds, considers, and declares that the reimbursement of the Authority for the payment of such expenditures will be appropriate and consistent with the objectives of the Authority's programs and, as such, chooses to declare its intention, in accordance with the provisions of Section 1.150-2 of the Treasury Regulations, to reimburse itself for such payments at such time as it issues obligations to finance the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SOUTH TEXAS WATER AUTHORITY THAT:

Section 1. This Resolution declares the intention of the Authority to reimburse the expenditures for the Project with the proceeds of obligations. The Authority presently intends to reimburse the expenditure by incurring obligations issued under Texas law, the interest on which is excludable from gross income under section 103 of the Internal Revenue Code of 1986, as amended.

Section 2. The Authority reasonably expects to incur debt, in one or more series of obligations, in an aggregate maximum principal amount now estimated to be \$7,600,000 for the purpose of paying the costs for the acquisition of certain property and related improvements for the Authority.

Section 3. The Authority intends to reimburse the expenditures hereunder not later than 18 months after the date the original expenditure is paid or the date the Project is placed in service or abandoned, but in no event more than three years after the original expenditure is paid unless the Project is a construction project for which the Authority and a licensed architect or engineer have certified that at least five years are necessary to complete the Project in which event the maximum reimbursement period is five years after the date of the original expenditure.

Section 4. The Authority intends that this Resolution satisfy the official intent requirement set forth in Section 1.150-2 of the Treasury Regulations and evidences its intentions under Section 1201.042(c) of the Code.

Section 5. This Resolution shall be liberally construed to evidence the intent of the Authority to comply with state law and federal income tax law in the issuance of tax-exempt obligations for the Project.
